

## Interest rates on bank deposits – France • June 2019

### The Interest rate on bank deposits is roughly unchanged in June

In June 2019, the average interest rate on bank deposits decreases very slightly over a month (0.60%, down from 0.61% in May). This rate decreases by 5 basis points year-on-year (0.60% in June, down from 0.65% in June 2018). The decrease observed over the last 12 months is mainly driven by deposits with agreed maturity over 2 years, whose remuneration fell by 29 basis points for households and 21 basis points for NFCs.

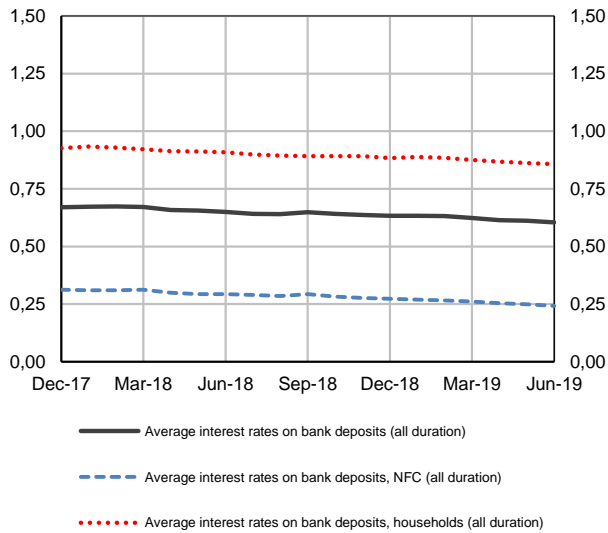

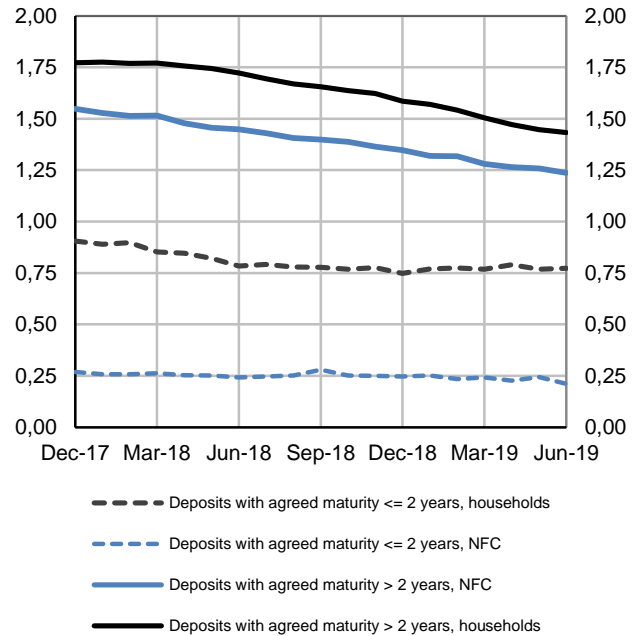

Remuneration on deposits with monetary financial institutions

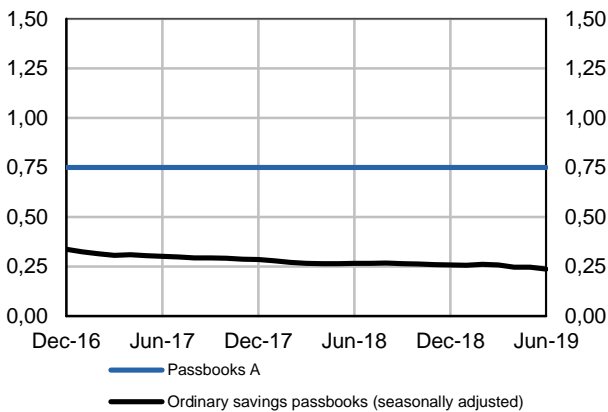
Households and NFC's deposits (in %)



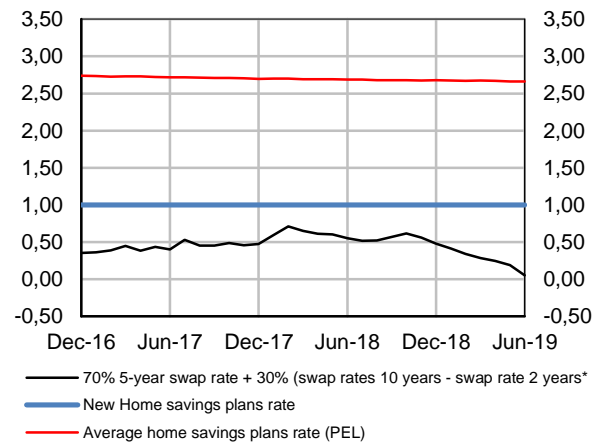
Households and NFC's deposits with agreed maturity by duration (in %)
